On behalf of myself, my child(ren), my ward(s) or heirs, assigns, and personal representatives, I agree to release, relief, indemnify and hold harmless the City against any and all claims, demands, damages, judgments, costs and expenses, including reasonable attorney's fees for the defense of such claims and demands arising as a direct or indirect result of the use of City facilities, or participation in or attendance at City of Belton programs/activities, the Parks and Recreation Departments programs/activities, the Youth Advisory Commission programs/activities, and/or Harris Community Center activities, by myself, my child(ren) or my ward(s). In case of any such claim, I agree to defend the action or proceeding by counsel acceptable to the City.
